**BEING A BYLAW OF THE VILLAGE OF CARBON IN THE PROVINCE OF ALBERTA, TO AUTHORIZE THE VILLAGE OF CARBON TO TAKE THE NECESSARY ACTION TO ESTABLISH A REGIONAL WATER SERVICES COMMISSION.**

**WHEREAS:** the Village of Carbon wishes to participate in the establishment of a regional water services commission pursuant to Part 15.1 of the Municipal Government Act, (R.S.A. 2000, c. M26 as amended);

**AND WHEREAS:** by virtue of the power conferred upon it by the Municipal Government Act, the Council of The Village of Carbon, Duly assembled enacts as follows:

**SECTION 1**

**SHORT TITLE**

- 1.1 This By-law shall be known and may be cited as the "Regional Water Services Commission Authorization By-Law" of the Village of Carbon.

**SECTION 2**

**REGIONAL WATER SERVICES COMMISSION**

- 2.1 The Council of the Village of Carbon is hereby authorized to make any necessary agreements and take the necessary action together with the Council of any other Municipality of Municipalities for the establishment of a regional water services commission pursuant to Part 15.1 of the Municipal Government Act.

**BEING A BYLAW OF THE VILLAGE OF CARBON IN THE PROVINCE OF ALBERTA, TO AMEND THE RECORDING OR THIRD READING OF BYLAWS OF THE VILLAGE OF CARBON.**

**WHEREAS:** the provision of the Municipal Government Act, Revised Statutes of Alberta 2000 Chapter M-26 and all amendments thereto, empower Council to pass Bylaws;
